Minutes

On motion made by Comptroller Schaefer, and seconded by Treasurer Kopp, the Board approved the minutes of the October 18, 2005 regular meeting

Investment
Committee
Recommendations and
Information Items

2 Treasurer Nancy Kopp, Vice-Chairman of the Investment Committee, reported on the meeting held November 10, 2005

Treasurer Kopp reported on the following information items discussed at the Investment Committee meeting

- Ennis Knupp made an educational presentation on the role of the custodian and securities lending, reviewing the System's reliance upon State Street affiliates for custody, securities lending, asset management and transition management. They indicated that this reliance upon State Street is similar to its peers, calling this a common model for large public pension plans.
 - The TUCS report_was_received for the_quarter_ending_ September 30, 2005, indicating that the System was in the 63rd percentile for the most recent quarter, and in the 59th percentile for the 12 month period ending September 30, 2005. For two, three and four year percentiles were 50th, 47th, and 60th respectively

Treasurer Kopp also noted the importance of discussions to occur at the Investment Committee in January concerning the use of active or passive management and a review of the managers in the System's domestic equity program. She recommended that all Trustees attend this important meeting

The Board accepted Treasurer Kopp's report on items reported by he Investment Committee in open session

Executive Director's Report

3 Mr Lee stated that the Joint Committee on Pensions (JCP) reviewed the System's investment results for FY2005 on November 8, 2005. The JCP did not reach any decisions, holding off until later in the year when more information will be available on potential funding for retiree health care costs. He stated that the JCP wants to consider all major funding issues (health benefits, corridor funding and benefit enhancements) prior to making any decisions for 2006 legislation.

Mr Lee noted that the legislative auditors were at the Retirement Agency to perform a compliance audit, which is performed every three years. The auditors are expected to be in the office for about four months.

Mr Lee stated that Vincent Marsiglia and Melody Countess were in the process of finalizing the information for the 2005 Comprehensive Annual Financial Report. It would be available to the Trustees at the December meeting.

Medical Board Reports

4 On motion made by Treasurer Kopp, and duly seconded, the Board accepted the reports of the Medical Board in connection with applications of members for ordinary, accidental and special disability retirement allowances. The Medical Board's conclusions were reached after its review of the documentation provided by the claimants.

Supplemental Medical Board Reports

On motion made and duly seconded, the Board accepted the supplemental reports of the Medical Board in connection with application of members for ordinary, accidental and special disability retirement allowances. Before hearing disability appeals, Mr. Lancaster briefed the Board on the recent NEA meeting that he and Mr. Brown attended. He noted that Dr. Thomas Mackel, Federal Reserve Bank of Richmond, had talked on the role of trustees touching on many issues that were pertinent to Maryland. He suggested that Dr. Mackel would make an excellent presenter at the next Board educational retreat.

Teresa L Spencer

6 The Board considered the report of the Medical Board and the proposed findings of the Administrative Law Judge in connection with the claim of Ms Teresa L Spencer for disability benefits. A report by the Medical Board, the Administrative Law Judge's report, and all related documents submitted by the parties were presented.

Ms Spencer's case was heard on the record. She did not appear before the Board to oppose the Agency's position and the Administrative Law Judge's recommendations. The Board deferred further consideration to Executive Session.

Dorothy R Smith

7 The Board considered the recommendation of the Administrative Law Judge in connection with the claim of Ms Dorothy R Smith for accidental disability benefits. The Administrative Law Judge's Proposed Decision, a report by the Medical Board, and all related documents submitted by the parties were presented.

Ms Smith addressed the Board via telephone to oppose the Agency's position and the Administrative Law Judge's recommendation. Ms Carla Katzenberg, attorney for the Agency, addressed the Board and argued that the Board should adopt the Administrative Law Judge's recommendations. Following discussion, the Board deferred further consideration to Executive Session.

Darlene Benedict-Samaras

The Board considered the recommendation of the Administrative Law Judge in connection with the claim of Ms. Darlene Benedict-Samaras for accidental disability benefits. The Administrative Law Judge's Proposed Decision, a report by the Medical Board, and all related documents submitted by the parties were presented.

Ms Benedict-Samaras appeared before the Board to oppose the Agency's position and the Administrative Law Judge's recommendations Ms Carla Katzenberg, attorney for the Agency, addressed the Board and argued that the Board should adopt the Administrative Law Judge's Proposed Decision Following discussion, the Board deferred further consideration to Executive Session

Patricia Smith-Rice

The Board postponed the appeal of Ms Patricia Smith-Rice on recommendation of the Secretary for the Board who advised that Ms Smith-Rice just retained the services of an attorney. Her appeal is to be rescheduled for a future date.

The Administrative Law Judge's report, a report by the Medical Board, and all related documents submitted by the parties were presented.

Ms Yates appeared before the Board to oppose the Agency's position—and the Administrative_Law_Judge's_Proposed Decision __Ms _Laura__ Burns, attorney for the Agency, addressed the Board and argued that the Board should adopt the Administrative Law Judge's Proposed Decision Following discussion, the Board deferred further consideration to Executive Session

On motion made and duly seconded, the Board voted unanimously to meet in Executive Session to deliberate disability appeals, pursuant to State Government Article, Section 10-503(a)(1)(iii) which authorizes the Board to meet in closed session to carry out a quasi-judicial function
