Adoption of Final COMAR Regulations

Ms. Anne Budowski reported that the amended regulations concerning Domestic Relations Order (COMAR 22.01.03) and Membership in the Employees' System or the Teachers' System – General (COMAR 22.04.02), which were originally brought to the Board for its approval in July, received no comments and were being presented for final adoption.

Mr. Hughes recommended and Mr. Harkins agreed that the Administrative Committee would look into a mandatory surviving spouse benefit for the Employees' and Teachers' systems.

Mr. Blitzstein reported that the National Academy for Social Insurance issued a pamphlet addressing the issue of when to apply for a social security benefit. Mr. Blitzstein will forward a copy of the pamphlet to Mr. Kenderdine and Ms. Bury for review.

On a motion made by Mr. Hughes and duly seconded the Board approved for final adoption the amended regulations regarding Domestic Relations Order and Membership in the Employees' System or the Teachers' System – General.

Executive Director's Report

Ms. Margaret Bury provided the Board with a copy of the correspondence that the American Federation of State, County and Municipal Employees (AFSCME) would be mailing to appropriate retirees of the System.

Ms. Bury indicated that the Agency does not release the names and addresses to AFSCME directly but provides the names and addresses to the mailing vendor contracted by AFSCME to perform the mailing.

CIO Report

Dr. A. Melissa Moye reported that final fiscal year end information was not yet available.

Dr. Moye reported that the total market value of the fund, as of the end of May, was \$44.9 Billion. Dr. Moye reported that preliminary reports show an asset amount just under \$45.3 Billion, as of June 30, 2014. The fund return at the end of May, 2014 was 12.9%, with a three-year average of 7.45% and a five-year average of 11.3%.

Mr. Douglass provided to the Board a document he produced entitled "Bang for the Buck," which he indicated provided a comparison of the System returns and those of the S&P 500 Index over various time periods. Mr. Douglass requested that a copy of this document be made a part of the Board minutes.

Treasurer Kopp stated that she had requested a review and analysis of Mr. Douglass' report by both the System's actuarial firm and by the Chief Investment Officer and would share those reports with the Board.

Resolution Presentation
